Highlights

This analytical brief provides data on EU imports of organic agri-food products in 2024 and highlights key developments compared to 2023. Data on import volumes of organic products come from the Commission's online management tool TRACES (TRAde Control and Expert System). The import data are summarised in terms of origin and destination, as well as in terms of product classes and categories. Product classes and categories have been revised to be in line with the agri-food product nomenclature used by DG AGRI.

Volumes of imported organic products up by 6.4% in 2024

- Total imports of organic agri-food products in the EU increased from 2.48 million t in 2023 to 2.64 million t in 2024 (+6.4%). The increase reflected a rebound in demand after two years of decline caused by sharp increases in food prices.
- Most of this increase could be attributed to increased imports of organic fruit and vegetables (bananas, tomato preparations, juices), nuts, rice, oilseeds and cakes. On the other hand, a decrease was recorded in imports of organic olive oil, coffee, cocoa beans, maize and soya beans.

Fruit, vegetable and olive oil account for almost half of EU organic imports

- The EU is a major importer of organic fruit, vegetables and olive oil. In the total organic imports in 2024, this class of products accounted for 47.2% share of the volume.
- Imports of organic fruit, vegetables and olive oil in terms of volume increased by 6.4% to 1.24 million t in 2024, mainly due to a 26.4% increase in nuts (China) and a 4.5% increase in bananas (Ecuador), while imports of organic olive oil decreased.
- Imports of Arable crops and plant based products, which had a share of 38.3% in total organic import volume, increased by 8.3% to 1.01 million t. Growth was recorded in all product categories of this class, most notably in oilseeds and protein crops (+4.9%, incl. +17.9% for soy cakes), cereals (+9.5%, incl. +28.2% for rice), cereal preparations (+9.7%), sugar (+7.8%), vegetable oils (+24.2%) and other oils and fats (+20%).
- Imports of higher value organic products also mainly increased. Organic wine, beverages and food preparations imports grew by 12.9% to 68 thousand t, mainly due to a 17.7% increase in imports of mixed food preparations and ingredients.
- Imports of organic animal products grew by 9.4% to 25 thousand t, thanks to honey (+10.9%) and beef and veal (+67%). Imports of non-edible and non-agri organic products increased, respectively, by 28.4% and 26.1%, but imports of organic Coffee, tea, cocoa and spices fell by 7.3% to 229 thousand t.

Olive oil remains the most imported organic product

- With 35 thousand t out of 221 thousand t being organic, olive oil remains the most organic agri-food product subcategory imported into the EU in 2024, with a share of 15.9%. However, this is a significant decrease from 24% recorded in 2023. Almost all imported organic olive oil (99%) is of extra virgin quality and is imported from Tunisia.
- Among the other products with a significant organic share in imports in 2024 were bananas (13.4%), spices (e.g. ginger) (13.2%), prepared or preserved grapes (12.5%), aromatic plants for technical use (12.3%), white sugar (10.5%) and prepared or preserved pears (10.3%), and most of them saw this share increase compared to 2023.

Ecuador increases the lead among the top origins of organic imports, China and Ukraine record big gains


- Ecuador continues to reign at the top of the exporters of organic products to the EU, with a further increase in volumes of exports of organic bananas (+10%). The Dominican Republic, once 2nd main country of origin, dropped to 5th place after its exports of organic bananas decreased again (-12%).
- Imports of nuts and spices from China almost doubled, which helped the country stay as the 2nd most important country of origin (+19%). Imports from Ukraine also increased (+17%), mainly due to higher imports of organic oilseeds (+23%) and cereals (+8%), propelling the country up to 3rd most important country of origin of organic products. Peru remains 4th with a modest increase in imports (+4%).
- Imports from India grew fastest among the top suppliers (+40%), thanks to an increase in organic rice imports. On the other hand, sharp declines in organic imports were registered for Togo (-15%, mainly in soya beans) and Tunisia (-18%, in olive oil).

Netherlands remains the EU's top destination, imports by Member States joining EU after 2004 grow by 25%


- The Netherlands remained the top destination of organic imports into the EU and also saw a significant increase in total volumes (+17%). Germany (+2%) and Belgium (+13%) remained 2nd and 3rd destination, while Italy (+6%) remained 4th after imports into France (5th) fell notably for the second year running (-14%).
- Among other main EU importers, Sweden reduced organic imports again (-13%), while Denmark (+20%) leapfrogged Spain (-12%). Imports into Ireland were stable (+1%), while in Austria, they fell sharply (-26%, maize, apples, grapes).
- The Member States that joined EU after 2004 saw an increase in organic imports (+25%), most notably Poland (+11%), Czechia (+41%) and Romania (+244%). Overall, the share of these countries in the total EU imports of organic products increased from 3.2% in 2023 to 3.8% in 2024.


GRAPH 1 – Share of organic agri-food import volumes by class, 2023 (inner circle) and 2024 (outer circle)




GRAPH 3 – Organic agri-food import volumes by import country (million t)



GRAPH 5 - Main product categories of organic agri-food imports by exporting country, 2024 (million t)




GRAPH 2 – Share of organic agri-food imports in value by class, 2024




GRAPH 4 – Share (%) of organic agri-food import volumes by export country 2023 (inner circle) and 2024 (outer circle)




GRAPH 6 – Share (%) of organic agri-food import volumes by product category, 2023 (inner circle) and 2024 (outer circle)




GRAPH 7 -Share of organic import volumes in total agri-food imports for top ten product sub-categories




GRAPH 9 – Organic arable crops and plant-based products import volumes by exporting country, 2024 (million t)




GRAPH 11 - Organic animal product import volumes by exporting country, 2024 (thousand t)
